1A UNVEILING OUR NEW CONSERVATION EASEMENT AGREEMENT TEMPLATE

Conservation easements protect the natural features of a property without a land trust taking on the responsibilities of ownership. Work through a new easement template and get caught up on recent court decisions. 1B CLIMATE CHANGE IN ONTARIO: HOW DO LAND TRUSTS PREPARE THEMSELVES?

Climate change is one of the most important causes globally for ecosystem change and species extinctions. Land conservation is important for preserving refuges and corridors, which may help ecosystems and species to survive in a changing climate. The Ontario land trust community plays an important role in land conservation in south-central Ontario. But how are Ontario land trusts preparing themselves for climate change, to most effectively address this environmental concern? Based on the results of a survey of Ontario land trusts, here we report on land trusts' views of climate change and the circumstances that affect land trusts' responses to climate change. We discuss steps land trusts might take to become more effective in addressing climate change.

SPEAKER BIOGRAPHIES

Allyn Abbott, Director, American Friends of Canadian Land Trusts

Allyn Abbott joined the Board of Directors of American Friends at the beginning of 2017. Allyn lives in Gravenhurst, Muskoka, Ontario where she has served on the board of the Muskoka Conservancy, one of American Friends' partner land trusts including 6 years as the president. Allyn's background as a biologist with Environment Canada followed by a career as a lawyer is a good match for American Friends' work to protect Canada's ecologically significant landscapes. "I joined the American Friends to get involved with their important work of helping Americans to permanently protect wild spaces in Canada. Because some of the properties have been owned for generations, the families have a deep love of their land and are eager to ensure that their properties are preserved forever."

lan C. Attridge, Barrister and Solicitor

Ian Attridge is an ecologist and lawyer based in Peterborough (Nogojiwanong), the traditional territory of the Mississauga Anishinaabe. He practices and teaches environmental law and is a conference speaker and author of numerous publications and policy submissions. He has advised many land trusts in Ontario and governments at all levels, including the Ministries of Natural Resources and Environment. Over the course of his 35 year career, lan has led the protection of over 17,000 acres of private and public lands and the formation or update of some 20 organizations. He has also led the development of the legal framework for land securement and related tax incentives in Ontario. Ian has been OLTA's Vice President, Chair of Government Relations, and an active member of its Conservation Easement Agreement Working Group. A keen naturalist, he enjoys outdoors activities, singing, and fostering sustainable communities.

Dan Cooper, Director of Conservation Lands and Stewardship, Rideau Valley Conservation Authority

Dan Cooper is the Director of Conservation Lands and Stewardship at the Rideau Valley Conservation Authority. He has worked for Conservation Authorities for 19 years with the last 17 being at Rideau. He has spent the better part of his career with the tree planting program at Rideau Valley Conservation Authority. He works closely with the Rideau Valley Conservation Foundation. The Foundation's land program is the highest priority in their current strategic plan.

Karen Cooper, Drache Aptowitzer LLP

A partner with the firm, Drache Aptowitzer LLP, Karen is recognized as a leading expert by Lexpert and Best Lawyers practicing charity and not-for-profit law with an emphasis on tax issues at Drache's Ottawa office, having formerly been a Senior Rulings Officer with the Income Tax Rulings Directorate of Canada Revenue Agency, as well as former counsel for the Department of Justice in tax litigation. Karen also has considerable teaching experience, including as part-time professor at the University of Ottawa, Faculty of Common Law, and is a contributing author to The Management of Charitable and Not-for-Profit Organizations in Canada (LexisNexis Butterworths). She is past Chair of the Canadian Land Trust Alliance, a big supporter of her local land trust (RWLT) and Vice-Chair of her local hospital.



Michael Drescher, Associate Professor, University of Waterloo

Michael Drescher started his academic career at Ruhr-Universität Bochum (Germany) studying biology, then continued at Utrecht University (Netherlands) with life sciences, followed by obtaining a PhD from Wageningen University (Netherlands), School of Production Écology and Resource Conservation in 2003. He joined the Ontario Ministry of Natural Resources and Forestry in 2005, and completed postdoctoral research at the University of Toronto and University of Guelph. Dr. Drescher's tenure at the University of Waterloo began in 2010, being appointed an Associate Professor in 2015, teaching ecology, environmental policy, and rural development. He is also Director of the Heritages Resources Centre at the University of Waterloo, focusing on natural heritage systems. Dr. Drescher's research has been published in leading international journals including Climate Research, Conservation Letters, Ecology & Society, Journal of Applied Ecology, Journal of Environmental Planning and Management, and Rural Society.

Antoin Diamond, Director of Land Acquisition and Management, The Bruce Trail Conservancy

Antoin Diamond is a professional land use planner with The Bruce Trail Conservancy. Originally from the UK, she appreciates the importance of conserving natural heritage and of the powerful role land trusts play in this task. Antoin has specialized in land securement on the Niagara Escarpment since 2006. The position has given her insight into the tremendous benefits of working in partnership with local community groups, the private business sector, with fellow land trusts as well as government organizations to secure land. The BTC has secured thousands of acres and millions of dollars in donated land and funds. Integral to this success, Antoin has gained substantial experience in landowner relations, real estate transactions and land use planning policies and legislation needed to implement the numerous securement options available to landowners. Antoin holds an honours degree in Geography and GIS and Environmental Analysis from the University of Guelph and is member of the Canadian Institute of Planners and a registered member of Ontario Professional Planners Institute.

Laura Kucey, Habitat Biologist, EGP Coordinator, Environment and Climate Change Canada (ECCC)

Laura Kucey is the Ontario Regional Coordinator for the Ecological Gifts Program. With ECCC since 2010, Laura previously coordinated consultations under the Species at Risk Act on federal recovery documents. Prior to that, she spent four years with the Ontario Ministry of Natural Resources and Forestry in the Biodiversity and Lands and Waters Sections. Laura holds a B.A. in Biology and Geography from Colgate University and a M.Sc. in Zoology from the University of British Columbia. Her graduate work comprised of studying the effects of disturbance on Steller sea lions on remote islands in the North Pacific. In between degrees, Laura spent two years in Washington, D.C. working for National Geographic magazine.

Lisa McLaughlin, Vice President of Conservation Policy & Planning, Nature Conservancy of Canada (NCC).

A biologist (BSc) and rural planner (MSc) by training, Lisa has more than 17 years' experience in the management of conservation lands and the governance of private land conservation organizations. She has been a board member of the Ontario Land Trust Alliance, vice-chair of the Canadian Land Trust Alliance, is currently a steering committee member of the International Land Conservation Network, a member of the Privately Protected Areas working group of the World Commission on Protected Areas, and serves as a board member of the Canadian Committee of the International Union for Conservation of Nature (IUCN). In her free time, Lisa and her family enjoy cycling, hiking, canoeing, gardening and generally spending as much time as possible outside.



Paul Peterson, Barrister and Solicitor

Paul Peterson is a lawyer in private practice and has worked on behalf of property owners, land trusts and government agencies to complete many land conservation projects across Ontario. He has also been active in supporting the land trust community and worked on the development of the Canadian Land Trust Standards and Practices. Currently Paul serves as a Governor on the OLTA Board.

John Ross, President, American Friends of Canadian Land Trust

John is a dual citizen of Canada and the US. He is President of Dual, Inc. which serves as a capital allocation platform for portfolio businesses. Current companies and investments are focused in property services, business services, financial services and clean energy.

John has a keen interest in enabling crossborder conservation of Canada's natural lands, water, and habitat.
